AUDIT REPORT : 31-03-2022.

We have audited the Accounts of **Kle Society's Basavprabhu Kore Arts, Science And Commerce Mahavidyalaya Haleya Vidyarthigala Sangh, Chikodi** Tal: Chikodi, Dist: Belagavi for the year ended 31-03-2022 and the following are our observations thereon:

The Financial Statements are the responsibility of the Management. Our responsibility is to express an opinion on these Financial Statements based on our audit.

We have conducted our audit in accordance with the auditing standards generally accepted in India. Those Standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosure in financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the Management, as well as evaluating the overall financial statement presentation.

During the year under audit, the Accounts and Records of the Sangh maintained by the Staff are fairly well, but require some improvements. Other mistakes which are minor have been rectified by the staff at the time of our audit.

During the year, the Sangh has collected a Life Members of ₹.24,000/-, General Members of ₹. 2,27,350/- and Donor Members of ₹. 30,000/- Bank Interest of ₹. 21924/-. After charging the establishment expenses of ₹. 45,539/-, the Income & Expenditure Account of the Sangh shows a Deficit of ₹.23,615 /-.

We thank the Management & Staff of the Sangh for their co-operation at the time of our audit.


